I work for Fairfax County Park Authority's camp, Rec-PAC, which is held in elementary schools around Fairfax County. My site is Cardinal Forest Elementary, and we are an "inclusion site," meaning that in addition to "normal" campers, we have campers with mainstream disabilities. These include autism, mental retardation, muscular dystrophy, and others. The campers range from going into 1st grade to entering 7th grade.

Leonard Ignatowski and my father, Bruce Waxman, spoke to the entire camp about the Vietnam War on July 29, 2008. It was a very last minute arrangement, but luckily both veterans were able to come in and speak. Mr. Ignatowski gave a simple explanation of the war. He and my dad talked about their experiences. The kids asked questions and received candid answers.

The campers usually are very disobedient and do not listen to authority well. However, on this day, much to the surprise of myself and my co-counselors, they were very attentive to the guest speakers. They stayed quiet during the entire hour and asked many

questions. They really enjoyed having Mr. Ignatowski and my father come in to share their experiences. Later in the week the children wrote notes of thanks to the speakers, including pictures, which I delivered to my father.

LET'S GO "GREEN" AND EARN \$\$\$

Lets be the first "Green" chapter in VVA. The first step is to donate your empty printer ink cartridges to Staples Rewards Program. The chapter's account is under Leonard Ignatowski or Chapter 227 Vietnam Vets of Am, and the chapter earns \$3.00 for each HP, Dell, and Lexmark cartridges donated. A maximum of three cartridges per day is accepted. The program earned \$24.00 for the chapter in the last quarter rebate. At the same time, the chapter earns 10% rebate on each new ink cartridge, paper and copy service purchased by you. So let's use the Staples Rewards program to earn funds for the chapter. The next program is to donate your household goods and clothing to VVA's household goods program. Call for a free pickup or deliver them to the store in the old Levitz store on Gallows Road between Rte. 50 and Lee Highway in Merrifield. In recent visit there was a large number of shoppers in the store and a wide range of products from household goods to clothing for all ages.

The U.S. Postal Service is offering a free recyclable program for cell phones, digital cameras, ink cartridges, and other small electronic devices. Your post office should have a bag dispenser for mailing your device to the recycling center. The postage is FREE! Let's do our part, and make the world a little bit better for future generations. This program is one way to balance the environmental damage from our war.

TAX TIME: Charitable Deduction?

The last quarter of the tax year is at our door steps. Consider making a charitable tax deduction to the chapter. Your donation can be program specific such as the Vince Kaspar Awards Program, the Arlington County HILT summer school scholarship, the veteran assistance fund, or the general chapter management. 
