The February 19th membership meeting guest speaker is Professor Ronald Spector, a Vietnam veteran and George Washington University professor. FALLEN, BUT NOT FORGOTTEN

Col. Ward B. Nickisch's, USA (Retired), presentation on our country's MIA search destroyed any perception that it is not being performed with the highest degree of dedication and urgency. He is a Vietnam veteran and commanded the army's Central Identification Laboratory in Hawaii. The entire recovery from the site search to remains interment and its many challenges were discussed. The lab's recovery operations span the globe, including in the U.S. The enemies are the passage of time, fading memories, terrain change, and open water losses. The jungle environment quickly deteriorates the remains, while the Korean cold preserves it longer. The current count includes approximately 120 lost in the Cold War, 1700 lost in the Vietnam War, 8,100 lost in the Korean War, and 78,000 lost in WWII. The first Gulf War has one MIA. Ward was involved with identifying the Vietnam Unknown Soldier at Arlington National Cemetery. Modern laboratory technology and DNA is making almost 100% identification possible, especially with the collection of DNA from every new soldier.

The staff's dedication was highlighted at a radar site in Laos that had been attacked, and four of the eleven U.S. personnel remains could not be found on the mountain top. The NVA commander was flown to the site. He pointed out where the soldiers made their last stand. The team returned to Hawaii to make mannequins based on the missing soldiers' physical features. The mannequins were dropped into the jungle from the last fighting position, and their remains were found within a hundred feet of where the mannequins landed. It was also learned that when President Clinton normalized diplomatic relations with Vietnam to the consternation of many veterans, the Vietnamese government permitted the American flag to drape the caskets on their way to the airport. Until this time, our flag was placed over the casket only when it was inside U.S. aircraft.

One obstacle involved searching for remains in Laos. The Laotian government would not assist since it was claimed that the North Vietnamese occupied the country at that time. North Vietnam said that was not true since they did not want to acknowledge their presence at that time. The resolution was to have a joint-task force of U.S., Laotian, and Vietnamese personnel.

In response to a question about live MIA/POW reports, Ward explained that they were mostly Europeans who were involved with aid projects. He did tell the story of a successful resolution of a U.S. live sighting. An army master sergeant suffered amnesia after arriving at McGuire AFB. A California family accepted him as a homeless person. When the couple died, a social security worker in processing his benefit claim discovered that his name was not in the database. However, the soldier mentioned another name that he remembered and the worker went the extra mile to investigate. The new search showed that the name was of an MIA. A medical examination confirmed his identity and cleared him of any wrongdoing. He was returned to active duty as a 71 year old sergeant. He retired based on his service up to his return from Vietnam and united with his family. A name was removed from the MIA list with a happy ending.

Ward's presentation dispelled any reservations regarding our dedication to recovering missing soldiers. He will give his presentation to any group within a reasonable drive of his home. He can be contacted at wardnick@aol.com.

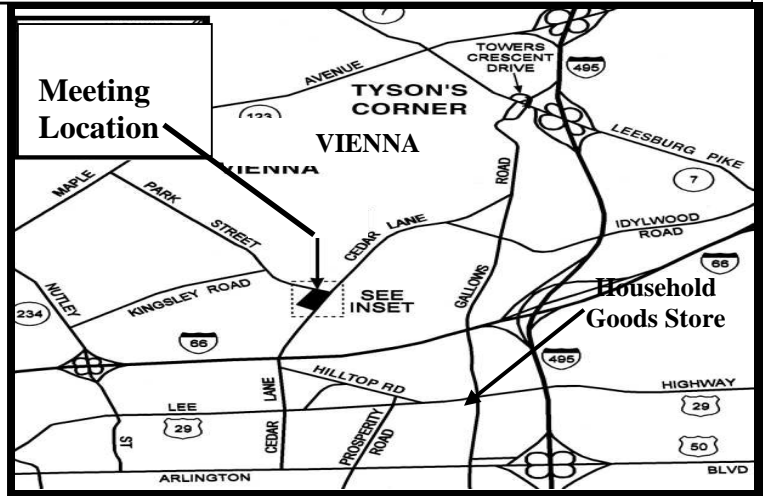
