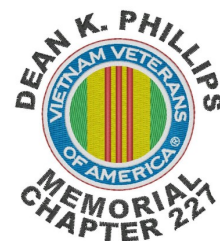

He served as the university's Director of the Command and Control Research Program. He will discuss senior U.S. military constitutional command responsibility in domestic and international turbulent times. He is currently Professor of National Security Studies at the National Defense University in Washington D.C. This is an excellent opportunity to separate political talk from the facts.

32nd Anniversary Celebration

With a full house, the chapter's 32nd anniversary celebration was a great success on October 19th. Special guests were Mary and Carl Stout, chapter founding members. Mary was the second VVA President and first woman to command a national veteran organization. She served as a nurse in the Army's 2nd Surgical Hospital at An Khe and Chu Lai in Vietnam in 1966-67. Other guests were Jennifer Morgan and Jim Samuels, post 9/11 veterans. Jim was presented with a Veterans/US Flag pin. Two other guests were Tom Grant, Veterans Services Coordinator of Loudoun County and Tom Davis of the Veterans Court Docket. Callie Wright, the Vietnam Veterans Memorial Fund Education Programs Manager also attended.

The auction generated \$328 while the 50/50 raffle resulted in \$77. Special thanks to Jonathan Olson for conducting the 50/50 raffle for many years. Also, George Jones continues to donate a custom wood carving for the monthly raffle. Len Ignatowski won the member recruitment drive with nine new members and received the \$ 50 Glory Days Grill gift certificate. Bruce was second with seven members. Our membership count is 288 and is the 25th largest VVA Chapter.

Marc Leepson, Vietnam veteran and chapter member, gave a

very informative biography of Barry Sadler, Vietnam Green Beret fame. Barry was a pre-Vietnam War Air Force veteran. After his discharge, he enlisted in the Army since the Air Force recruiter was out-for-coffee. The macho Special Forces appealed to him since he mastered the Samurai warrior code and several Japanese martial arts when stationed in Japan. He was trained as a combat medic and served on several teams before a punji stick injury resulted in stateside treatment. When the Special Force recruitment was searching for a model, Barry was recommended due to his guitar playing and singing. His written song, Ballad of the Green Berets, became an instant hit and rose to #1 on the national song charts and eventually the #1 song for 1966 with 9 million singles. His very tough competition was the invading popular English bands (Beatles for one). After leaving the Army his movie and singing careers collapsed and he quickly lost his \$500,000 song royalties in a series of business failures and personal spending on WWII souvenirs. He discovered a new talent, fictional book author. His successful 29 books were based on the mystical character, Casca. His face appeared in each book cover. After being shot in Guatemala under suspicious conditions, he was brought to a VA hospital in the US. His mother and personal lawyer abducted him from the VA hospital to a private hospital for treatment. Barry died on November 5, 1989. His entire story is available in Marc's book, "Ballad of the Green Beret".

Holiday Cheer for Distressed VASH Veterans and a Wounded Warrior Family

The chapter's annual Holiday Cheer program includes providing a \$50 gift card to financially distressed VASH veteran and family and filling a Wounded Warrior family Christmas list. The VASH team leader provides the number of their veterans in financial assistance for the Holidays, while the Ft. Belvoir Hospital POC provides the Christmas list of a Wounded Warrior family Christmas list. The latter name remains anonymous and the family is staying in the area while the warrior is being treated. In past cases, the warrior sustained serious combat injuries. The chapter budget for the Wounded Warrior family is \$ 500. The number of VASH families from last year was sixty-four \$50 gift cards.

Donations are being solicited for these two outreach programs with the objective of honoring all needs and maybe increasing the amounts. 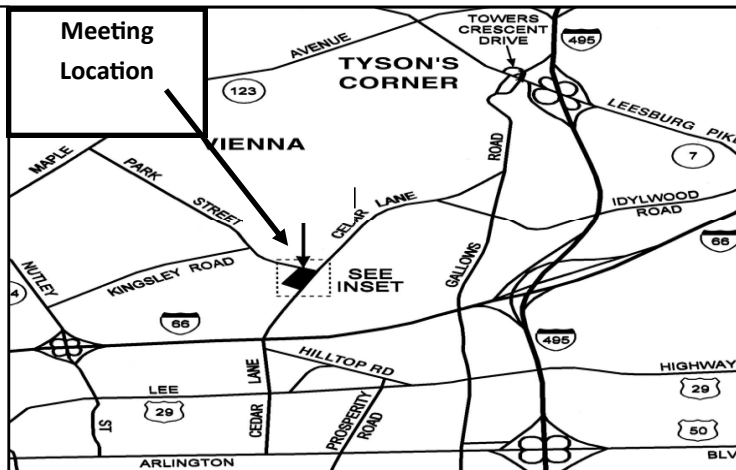

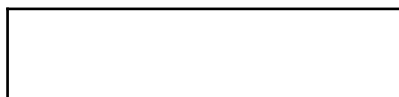
